HRSA Requirements for Strategic Plans

- 1. Address the gaps in the opioid use disorder (OUD) prevention, treatment (including MAT), and/or recovery services, as well as access to care identified in the analysis.
- 2. Incorporate evidence-based, promising, and innovative approaches proven to reduce the morbidity and mortality associated with opioid overdose in rural communities.
- 3. Ensure affordability of and accessibility to services for target populations.
- 4. Detail plans to leverage existing federal, state, and local OUD resources and secure community support.
- 5. Provide specific strategies for implementing evidence-based, promising, and innovative practices after the project year ends.
- 6. Develop strategies to eliminate or reduce costs of treatment for uninsured and underinsured patients.

RCORP-P Strategic Planning

- (Federal: HRSA) RCORP-P Strategic Plan should flow from the RCORP-P Needs Assessment.
- (Federal: HRSA) RCORP-P Strategic Plan needs to dovetail the RCORP-I grant submission and requirements for implementation.
- (State: OhioMHAS/ODH) RCORP-P Strategic Planning process is congruent with the existing tools.
- (Local) RCORP-P Strategic Plan needs to work in synergy with existing strategic plans.

Strategic Planning: Prioritization
