### **TA Constraints**

- Planning grant was intensive and fast. As such, TA support needed to "match the ask."
- Implementation grant provides more time to do the work and be innovative in our approach – including how we support one another.
- Due to the level of funding given to each community for implementation, OU and PIRE need to consider how best to deliver wrap-around support while being fiscally responsible with our budgets.





### TA Needs: What we Know

- More connections with one another and more peer-to-peer sharing
- Point person as questions arise
- Explore working directly with one another and how to best utilize (pooled) resources
- Implementation = more time for work and planning and more space for innovation
- Budgetary considerations = important to determine best use of resources

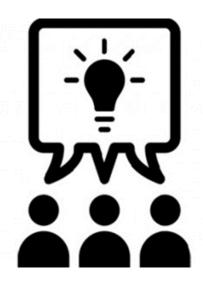

#### **RCORP-I Core Activities**

- RCORP-Implementation requires that we successfully implement on 15 Core Activities
  - 6 prevention-focused
  - 6 treatment-focused
  - 3 recovery-focused
- In addition, we have to execute on two sustainabilityrelated Core Activities
- At the proposal stage, we created two workplans to support our grant proposals
  - Ashtabula-Fairfield
  - Sandusky-Seneca-Washington
- We covered the 15 Core Activities across COP-RCORP local consortia.
  - Each local consortium will still need to focus on sustainability



### **RCORP-P Strategic Plans**

#### <u>In addition</u>:

- Seven data-driven plans were created by each local consortium as part of the RCORP-P grant
  - Prevention—Demand Reduction
  - Prevention—Supply Reduction
  - Prevention—Harm Reduction
  - Treatment
  - Recovery Supports
  - Workforce Development
  - Sustainability
- Key questions to think about for our November meeting:
  - How do we move forward together?
  - What will we prioritize the plan for Year 1?
  - What opportunities are there for shared services?



# Workgroups and Opportunities for Expanded Collaboration

Another thing that the work we are about to engage on affords us:

- Shared services agreements (cost sharing)
- Opportunities for collaboration, idea generation, and problem solving.

The question becomes: How can we create an environment where local consortia can utilize each other as resources?

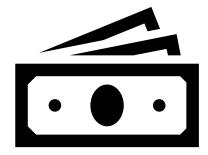
